

Only one application is required per school year. Application deadlines can be found on our website at [www.schoolchoicearizona.org](http://www.schoolchoicearizona.org).

**School Choice Arizona can only make an award if your student is currently attending, or in the enrollment process for the school named on your application.**

All applications expire at the end of every school year, regardless of when they are received.

### HOW ARE SCHOLARSHIPS AWARDED AND WHAT FACTORS ARE CONSIDERED?

Our Selection Committees consider three factors when making Original and Overflow award decisions:

- 1 Financial Circumstances of the Student's Family  
*(A required factor by state law. It is held in strictest confidence.)*
- 2 A Narrative Provided by the Parents
- 3 Donor Recommendations Concerning the Student

**Every student who has a current application on file and the meets the qualifications of each type of scholarship is considered.** If a student does not receive an award, it is simply because there wasn't enough to go around.

### WHAT IF MY STUDENT RECEIVES AN AWARD BUT TRANSFERS TO ANOTHER SCHOOL?

As long as the new school is a private school in Arizona that partners with School Choice Arizona, the unused portion will follow the student. Otherwise, any remaining scholarship amount would be awarded among other students at that school.

### MAY A STUDENT RECEIVE FUNDS FROM MORE THAN ONE STO?

Yes, we encourage you to apply for any opportunities available. **Our number one goal is for you to be able to afford a Private Education for your child.**

### IF MY STUDENT RECEIVES EMPOWERMENT SCHOLARSHIP ACCOUNT (ESA) MONEY FROM THE ARIZONA DEPARTMENT OF EDUCATION, CAN THEY ALSO RECEIVE A SCHOLARSHIP FROM SCHOOL CHOICE ARIZONA?

The ESA statute (A.R.S. 15-2402 (B)(3)) requires that while a parent has a contract with the ESA program, a student cannot accept ESA and STO money for the same period. If a parent chooses to end their ESA contract during the school year, there is no conflict if the student receives an STO scholarship for the remainder of the academic year.

### DO WE AWARD TO FAMILIES?

Per the Arizona Department of Revenue, scholarship awards are only given to individual students. There are no family accounts. These awards are non-transferable, even within the same family.

## REGARDING SCHOLARSHIPS

### WHICH TYPES OF SCHOLARSHIPS ARE AVAILABLE?

School Choice Arizona awards four different scholarships, which are funded through tax credit donations from Individuals and Corporations. Arizona's two Individual Tax Credits fund School Choice Arizona's Original and Overflow awards.

Original Scholarships are funded through the Original Individual Tax Credit Law, enacted in 1997 as A.R.S. 43-1089. Any student enrolled in a Private School in grades K-12 (or a preschool student with disabilities) qualifies for this scholarship.

Overflow Scholarships are funded through the Switcher Tax Credit Law which took effect in August of 2012 as A.R.S. 43-1089.03. In order to be eligible for a scholarship from this source, students must fall under one of four categories.

- 1 Student is Switching from an AZ Public District/Charter school to Private School
- 2 Entering Kindergarten (or Preschool with a Disability)
- 3 Student's Parents are in AZ under Active Duty Military Orders
- 4 Student Previously Received Overflow or Corporate Scholarship

### HOW DO I RECEIVE A SCHOLARSHIP FOR MY CHILD?

Parents need to apply for scholarships online at [schoolchoicearizona.org](http://schoolchoicearizona.org). You may also download a copy of the application to print, and submit to us via mail, fax, or email ([info@schoolchoicearizona.org](mailto:info@schoolchoicearizona.org)). The same application is used for both Individual and Corporate Scholarships.

Please keep in mind that scholarships are not guaranteed and many factors are considered by our Selection Committees.

# REGARDING DONATIONS

## WHY SHOULD I DONATE TO SCHOOL CHOICE ARIZONA?

**WE EXIST TO GIVE PARENTS EDUCATIONAL CHOICE.**

## HOW CAN I DONATE?

## WHEN CAN I DONATE?

**You may donate at any time.** For donations made between January 1<sup>st</sup> and April 15<sup>th</sup>, it is up to the donor to claim the tax credit for the previous or current tax year. If claiming it for the previous tax year, **donations must be made by the time you file your taxes or April 15th, whichever comes first.** Even if you file an extension, **your donation must be postmarked or submitted online before midnight, April 15<sup>th</sup>.**

## HOW MUCH CAN I DONATE?

You can make a donation up to the combined maximum of the Original and the Overflow Tax Credits, or your Arizona state tax liability, whichever is less.

**Your state tax liability is the amount of money you must pay to the state in taxes based on your earnings.** In exchange for your donation, the state gives you a dollar-for-dollar tax credit, essentially taking the place of what you would have to pay to the state. **However your donation cannot exceed the annual donation maximum allowed or your tax liability, whichever is less.**

In order to claim the Overflow Tax Credit, you must donate the maximum amount to the Original Tax Credit first. Any amount donated above the allowed maximum for the Original Tax Credit pours over into the Overflow Tax Credit, up to that credit's allowed maximum donation.

If you have no liability, you cannot receive a credit. However, what you give to School Choice Arizona may count as a charitable gift for Federal deductions.

## IF I ALREADY GET A REFUND, WHY WOULD I NEED A TAX CREDIT?

You receive a refund because you have overpaid into your state taxes throughout the year.

A credit is very different from a refund. Dollar-for-dollar, a credit **offsets** the tax you owe the state. **Arizona gives you credit for each dollar you donate** up to your state tax liability or the stated maximum, whichever is less.

When you take advantage of a tax credit, if you normally get a refund, you'll get a bigger refund! Likewise, at the end of the year, if you typically owe tax, you'll owe less or now receive a refund.

## HOW MUCH OF MY DONATION IS AWARDED AS A SCHOLARSHIP?

Arizona law requires that 90% of donated funds are awarded as scholarships. School Choice Arizona awards **92%** of recommended donations, and uses the balance for operating costs and resources for our schools and parents.

## CAN I RECOMMEND A SPECIFIC SCHOOL OR STUDENT WITH MY DONATION?

Yes, you may identify a specific school and your donation will be used to award scholarships among applicants from that school. A current list of schools is available on our website. In addition, you may also recommend any student who is not your child or dependent.

However you cannot “swap” donations with another person by recommending each other's children. The law states, “A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent.”

## DOES A RECOMMENDATION GUARANTEE A SCHOLARSHIP?

No—School Choice Arizona's Selection Committees must retain complete discretion regarding all awards. Both Arizona law and IRS regulations do not allow guarantees. Recommendations are considered in the award process, but they are not the only factor.

## WILL I RECEIVE A RECEIPT AT THE END OF THE YEAR?

Yes, an annual receipt statement will be mailed to you by January 31<sup>st</sup> of the following year.

## IS OUR DONATION ELIGIBLE FOR A FEDERAL DEDUCTION?

We are a federally tax exempt 501(c)(3) charitable organization. For federal tax purposes, any deduction must be claimed for the tax year in which the donation was made; the April 15<sup>th</sup> deadline does not apply. You should consult your tax advisor for specific tax advice concerning deductibility for your tax situation.

## ARE THERE OTHER TAX CREDIT OPPORTUNITIES?

The state of Arizona offers several other tax credit opportunities. There are also the Public School Extracurricular, Charitable Organizations (Working Poor), Foster Care, and Military Tax Credits available. A taxpayer may donate to as many of the various tax credit programs as they like—so long as they have the state tax liability to do so. ## HOW DO I REPORT THE DONATION ON MY TAX RETURN?

Donations to School Choice Arizona for the Original Tax Credit are filed using Arizona Form 323. Donations made for the Overflow Tax Credit are filed using Arizona Form 348. If claiming any tax credits, you will also need to complete Form 301. Forms are available from the Arizona Department of Revenue at [azdor.gov](http://azdor.gov), or at [schoolchoicearizona.org](http://schoolchoicearizona.org).

## WHY CAN'T PARENTS KNOW WHO DONATED FOR THEIR CHILD OR HOW MUCH?

The Arizona Department of Revenue has always maintained that donor names should not be shared with scholarship recipients. By providing the names of donors who recommended a child for a scholarship, the STO may be giving the impression that money donated to an STO will always be used for the student beneficiary recommended by the donor.

A.R.S. § 43-1603(B)(3) prohibits an STO from awarding, designating or reserving scholarships based solely on a donor's recommendation. In addition, Federal charitable contribution laws expect donor confidentiality. We do not disclose dollar amounts for recommendations because there are no guarantees for the recommended amount. Tax credit law discourages any perception of an entitlement to scholarships that are not yet awarded.
