Directions

Before Cleaning:

Test for colorfastness by spraying in an inconspicuous area. If surface fades or fiber color transfers to a white cloth, do not use. Test first!

For Best Results:

Remove stains promptly after they occur and avoid over-wetting of carpets or fiber surfaces. Some pet stains will cause permanent discoloration even after cleaning if not treated immediately. Stains and odors are easier to remove if treated promptly.

Do Not Mix with Bleach or use in conjunction with any household products.

For Carpets, Upholstery, Clothes, & Washables:

1. Remove any solid residue from surface and blot up excess moisture with a clean, colorfast or white absorbent towel.
2. Saturate the problem area with the product and allow 5-10 minutes dwell time for penetration.
3. Apply enough to penetrate carpet padding and sub-flooring.
4. Blot or gently rub area with a clean, absorbent sponge or cloth; work inward towards the center of the stain.
5. Allow to dry. If white residue appears, simply vacuum.
6. For reappearing stains, repeat.

Ingredients: Biodegradable surfactants, anti-re-soiling polymers, wetting agents, enzymes and fragrance.

In Case of Spill:

- Wear suitable protective equipment. Eliminate ignition sources.
- Contain release by using an inert material such as sand or oil absorbent and/or eliminate the spill source.
- Take up and containerize for proper disposal.

- Do not discharge into sanitary sewer or storm sewer.
