- **Liaison for the Louisiana Interim Emergency Board at Governor's Office of Homeland Security August 2012 - Present** - This position is an additional duty where I assist local government and state agencies in identifying all potential funding opportunities afforded to them by the state to be used toward recovery from damage received as a result of natural or manmade events. Serve as GOHSEP's single point of contact to assist mayors, parish presidents and legislators for the Interim Emergency Board (IEB). Coordinate directly with the Commissioner's Office of Administration and the GOHSEP Director and all appropriate state agencies to assist in identifying funding related to the Interim Emergency Board.
- **Louisiana Army National Guard- Command Sergeant Major, 3-156 IN - November 1992 - Present** - Supervise an infantry battalion. Plan, coordinate, supervise, and participate in activities pertaining to organization, training, combat operations, and intelligence of units at battalion and higher.
