Funding for the Fort Collins Figure Skating Club Financial Distribution comes from the collective efforts of all members during fundraising activities. For the past year these have included Winter Wishes tables, Fort Collins Classic, sales of retail items at various events. The amount of available money varies from year to year.

QUALIFICATIONS FOR FINANCIAL DISTRIBUTION

1. Skater must be a current **Full Home Club member** of the Fort Collins Figure Skating Club (formerly the Ice Skating Club of Fort Collins) and have been a member for the previous full membership year July 1, 2012 – June 30, 2013. The one year commitment does not apply to Level A.
2. The skater and the skater's senior member have renewed membership for the current membership year July 1, 2013 – June 30, 2014, and that membership has not lapsed.
3. The skater is a "member in good standing" because the skater or someone on behalf of the skater has contributed to the club by volunteering at competitions or other club activities, and owes no money to the club.
4. This form is complete, accurate, and legible and signed by the skater or (if under 18) a parent.
5. **Valid receipts** from the said competition or event have been stapled to this request and submitted after the event has been attended. Valid receipts include coaches' fees, hotel and travel expenses, and entry fees. Cancelled checks are not valid receipts.
6. **Volunteer hours:** The skater, or someone representing this skater, has volunteered at competitions or events for the Fort Collins Figure Skating Club. A completed copy of the attached FCFSC Volunteer Log form must be submitted with this application. All required volunteer hours must be completed before a check will be issued. 7. **Applications must be submitted no later than June 30, 2014.** Checks will be completed by the 1st of every month if received by the 20th of the preceding month and checks will be made out to skater or parent of skater.

LEVELS OF FUNDING:

- Level A: Non-qualifying event/competition (including events such as Fort Collins Classic, Adult Sectionals non-qualifying levels), skating education, workshops, test session, Ice Theater during the current year (July 1, 2013 – June 30, 2014).
Only 1 distribution at this level is allowed per year per skater and for each synchro team as applicable.
- Level B: First level qualifying events:
- Midwestern (Juvenile-Senior, pairs and dance)
 - Adult Nationals (non-qualifying levels)
 - Adult Sectionals (qualifying levels)
 - Collegiate Nationals
- Level B(1): Southwestern Regional First Level Qualifying events (Juvenile - Senior singles events)
Southwestern Regional Non-Qualifying events (Beginner - Senior, Well Balanced Free Skate and Test Track; Compulsories; Pre-Juvenile Pairs/Dance)

- Level C: Second level qualifying events:
 - Adult Nationals (qualifying levels)
 - Midwestern Sectionals (singles)
 - US Nationals (pairs and dance)
- Level D: Third level qualifying event:
 - US Nationals (Singles)
- Level E: National Showcase (Singles, Duets)
- Level F: National Showcase (Theatre ensembles – financial distribution given to individual ensemble member – based on membership status)
- Level G: Synchro Midwest & Pacific Coast Sectionals (financial distribution given to individual team member – based on membership status)
- Level H: Synchro Nationals (financial distribution given to individual team member – based on membership status)
- Level I: Dance – National Solo Dance
