TEEN RESPONSIBILITIES

- _____ I will serve as a responsible role model when operating a vehicle to help teach good driving skills & habits to my teen.
- _____ If my teen is in an uncomfortable or unsafe situation involving alcohol or illicit drugs, I agree to come & pick him/her up, regardless of the time or place. If it is not possible, I will pay for a taxi to bring my teen home safely. There will be no argument at that moment, but a discussion of such an incident will follow at a later time. Likewise, I too agree not to drive if intoxicated, or ride with a friend who has been drinking or using illicit drugs.
