## *Overview*

- ❖ This contract outlines an agreement and included all contractual obligations made on \_\_\_/\_\_\_/\_\_\_ between Kimberly Gore Salon, hereinafter referred to as "Salon" and the "Guest," whose name appears on this form.
- ❖ Guest agrees to hire the Salon to provide hair services on the date and time agreed.

- ❖ Salon agrees to perform these services for the Guest and any wedding party members included in this contract, under the Terms and Conditions of this contract.

- ❖ Guest and Salon agree to the mutual promises set forth in this contract.

## *Salon's Obligation to Guest*

- ❖ Salon will perform the services promptly on the date and time agreed

- ❖ Salon will use their own products in the provision of the services.
  - Salon Agrees
- ❖ If on location, Salon will arrange a means of transportation to get to and from the event location.\*
  - Salon Agrees
- ❖ If Salon Employee is unable to perform services for any unforeseeable reason, or unavoidable situation, Salon agrees to arrange for an equally qualified Master Cosmetologist to complete the agreed upon services for the same agreed upon terms of payment in accordance with the Services Provision or Guest has the option of a complete refund\*

- ❖ Salon will use appropriate sanitary practices, and only use professional products that give high quality results, and that are safe (FDA approved) for the safety of the Guest and their wedding party attendents.\*
  - Salon Agrees
  
- ❖ Salon will be responsible for sub-contracting additional Master Cosmetologist or Salon Associates, for large bridal parties in order to perform the services required in an appropriate timeframe in accordance with the Services Provision. The need to hire sub-contractors will be at the discretion of the Salon, and will not be guaranteed unless specified with this contract.\*

### ***Guest Obligation to Salon***

- ❖ Guest agrees to pay all rates and fees in a prompt and timely manner as specified in the Payment Agreement.\*

- ❖ If the Salon is traveling, Guest is responsible for Salon's on-location Fee. Guest will pay all on location fees to Salon, in full, two (2) weeks prior to Ceremony Date.\*
  - I Agree
  
- ❖ Guest will provide the Traveling Artist with a safe and private work area at the location services are to be performed. This location will also provide the artist with the capability of performing their services as described, by providing an appropriate area (table/flat surface) to work from, appropriate lighting, and electrical outlets if necessary.\*

- ❖ Guest agrees to arrive to any agreed upon appointment times on time and failure to do so will result in extra charges after grace period has passed.\*
  - I Agree
  
- ❖ Guest agrees that Salon is only obligated to provide the services that are specified within this contract. Any additional services added on the Event Date will only be

accommodated if time allows and payment will be due in full on the Event Date before services are rendered. Salon cannot be held liable for any problems this presents abiding to the original timeline set in place.

### *Retainer*

- ❖ Salon will hold the Event Date in their calendar only after a non-refundable retainer fee of \$100.00 is paid.
  1. This deposit will be applied toward your total balance.
  2. The retainer fee can be paid prior to or at the consultation.
  3. Until this fee is paid, salon is within their right to commit to other appointments on your Event Date.
  4. The retainer fee is non-refundable should you cancel your event.
  5. The retainer fee cannot be transferred to another date or another individual, or another event.
  6. The retainer fee does not hold a cash value refund for gratuity.
- ❖ The retainer can be paid in the form of Cash, Money Order, or Credit Card.
- ❖ Guest agrees with the above retainers.

### *Balance Due*

- ❖ The remaining balance (total balance less retainer fee) is due, in full, two (2) weeks prior to the Event Date.
- ❖ The balance can be paid in the form of Cash, Money Order, or Credit Card.
- ❖ Regardless of any arrangements made between Guest and the wedding party, it is the Guest's Responsibility to ensure payment is made to Salon and failure of any additional attendant to pay their balance will be the sole responsibility of the Guest.
- ❖ Any additional services performed by Salon on the Event Date will be payable in full on the Event Date in the form of Cash when on location.
- ❖ Guest Agrees with the Above Policies for Balance Due.

## *Tardiness*

- ❖ Guest and wedding party will be scheduled for services at a specified time and are expected to arrive for their services at this agreed upon time.
- ❖ A thirty (30) minute grace period will be given, after which a "Wait Fee" will be incurred at a rate of \$25 per 15-minute wait time each for Salon's Artist(s).
- ❖ The Salon may have other Events to service on your Event Date and, if you are late, we may need to leave before all of the agreed upon services are rendered, due to time constraints.
- ❖ Payment for services agreed upon in this contract are payable, even if they are not rendered due to tardiness of Guest or members of the wedding party.
- ❖ Guest Agrees with the Above Tardiness Policies.

## *Cancellation Policies*

- ❖ In the event Guest must cancel services: The retainer fee will not be refunded.
- ❖ Fees for any services already rendered, such as Bridal Trail, are not refunded.

## *Entire Agreement*

This contract represents all the terms and conditions agreed upon by the parties. No other understanding or representations, oral or otherwise, regarding the agreement shall bind any of the parties. this contract may not be amended, expect in writing, and signed by both parties. In any action or proceeding involving a dispute between the Guest and the Salon arising out of this contract, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees.

### *Helpful Hints*

- ✓ All Bridal party members should come to their appointment with an idea of the look they would like to achieve. Photos are especially helpful for your hair
- ✓ Brides remember to bring your veil/hair piece or any other special touches you would like the stylist to add to your look the day of your Bridal Trail!
- ✓ All Bridal party members are advised to wear buttoned-down shirts.
- ✓ Extend Yourself. Don't shy away from having hair extensions for your wedding day: it's way less of a drama than it may sound. And no one needs to know--it can be our secret! Extensions are great if you want a little more length or fullness or if you are worried about your hair holding a particular style all through your wedding day. Even if your own hair falls, the extensions won't.
- ✓ Be product free on the day. On your trail day and wedding day, have clean, dry hair. Avoid using a lot of conditioner that morning, specially a leave-in one. Stay away from oily products that weigh your hair down, that makes it slippery to work with.
