**ORDER**

On March 13, 2018, Debtors filed their *Amended Joint Plan of Reorganization Dated March 13, 2018* (ECF No. 587) (“March 13<sup>th</sup> Plan”), which was then revised by Debtors’ filing of *[Revised] Amended Joint Plan of Reorganization Dated March 13, 2018 (as revised on March 16, 2018)* (ECF No. 594) (“Revised March 13<sup>th</sup> Plan”). An *Order* was entered by this Court on March 19, 2018, at ECF No. 600 recognizing that the Revised March 13<sup>th</sup> Plan superseded the March 13<sup>th</sup> Plan. A confirmation hearing on the Revised March 13<sup>th</sup> Plan is currently scheduled for April 24, 2018 at 10 a.m. See ECF No. 638. In advance of the April 24, 2018 confirmation hearing, the Court hereby

**ORDERS, ADJUDGES, AND DECREES** as follows:

1. A total of four (4) hours has been allotted for the April 24, 2018 confirmation hearing. The confirmation hearing shall begin at 10 a.m. and conclude promptly at 2 p.m.
2. If any party/parties believes that more time is necessary for the confirmation hearing, said party/parties must notify the Court in writing no later than April 19, 2018 and provide an explanation of why four (4) hours will be an insufficient amount of time to conduct and conclude the contested confirmation hearing.
3. Counsel for Debtors is to immediately serve this Order on all parties-in-interest.
