If the applicant provides a REAL ID Act of 2005 driver’s license or ID card as Proof of Identity and Age from LIST B, the applicant must also present <i>one (1)</i> of the following documents issued by the U.S. Federal Government verified through SAVE:	
	1. Unexpired immigrant or nonimmigrant visa status for admission into the United States
	2. Pending or approved application for asylum in the United States
	3. Admission into the United States as a refugee
	4. Pending or approved application for temporary protected status in the United States
	5. Approved deferred action status
	6. Pending application for adjustment of status to legal permanent resident or conditional resident
	7. Conditional permanent resident alien status
	8. Other documents as DHS may designate by notice published in the Federal Register
