



VEHICLE CERTIFICATION

The purpose of this form is to certify the type of vehicle driven by the Applicant for a Commercial Driver's License (CDL) or a Class E (CDL exempt) license. In most cases the Certification must be signed by the driver's employer. However, the Applicant may self-certify (sign as Certifier without an employer's signature) only if: a) the driver is renewing an existing CDL; b) the CDL driver is self-employed; c) the Class E Applicant is a recreational vehicle (RV) driver; or d) the Class E farm or ranch Applicant is the owner of the farm or ranch.

GVWR is the gross vehicle weight rating of the vehicle being driven by the applicant, and is the total weight of the vehicle itself <u>plus</u> the weight of the maximum load carried by the vehicle.
