Weight Holdings According to Risk

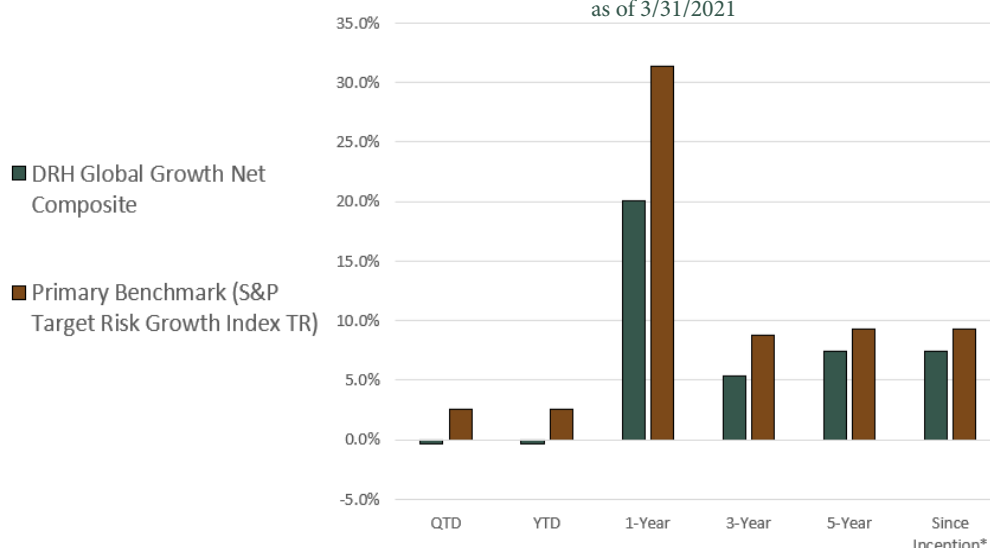
Daily portfolio optimization according to a strategic risk budget for each constituent. Rebalance as needed based on thresholds

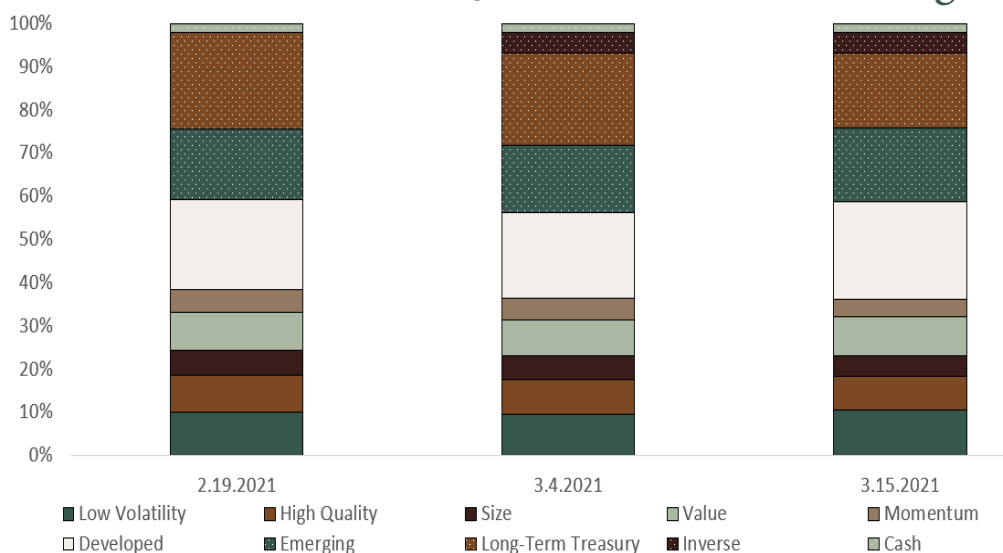

The strategy allocates risk primarily across five U.S. equity factors, developed and emerging markets, and U.S. Treasuries. The strategy also has the ability to take inverse positions and use cash to manage overall risk. The strategy is implemented primarily using exchange traded funds (ETFs) domiciled in the U.S.
