### Sexually Addicted Offender Program

#### Treatment Requirements

1. Individual Therapy
  - a. Initially this is at a level of time per week. Once group commences this may be moved to every other week based on clinical need.
  - b. Cost - \$175.00 per hour
2. Facing the Shadows Group
  - a. 12 week curriculum based group that is based on the workbook of the same name by Patrick Carnes.
  - b. Cost - \$50.00 per group
  - c. If attending more than one group at a time, a discount fee can be provided.
3. Group Therapy
  - a. Group therapy is a weekly group where attendance is expected each week.
  - b. Cost – either \$50.00 or \$70.00 per group depending on group length. Two hour group is \$70.00 and 1.5 hour group is \$50.00. Clients are placed in a group based on clinical fit with current group composition.
4. Shame Resilience Group
  - a. Group therapy done either weekly or in multi-hour mini-intensive sessions. Either 12 weeks (weekly) or 6 2-3 hour sessions.
  - b. Based on the curriculum of Brene' Brown
  - c. \$50.00 a group when weekly hour and a half group.
  - d. If attending more than one group at a time, a discount fee can be provided.
5. 12 step attendance
  - c. Attendance at SLAA, SA or SAA is recommended. Additionally, if AA or NA are warranted, attendance in these meetings is suggested as well.
6. Testing (if not done with another practitioner)
  - a. ABEL Screen – Cost - \$300.00
  - b. MMPI – Cost - \$150.00
  - c. SDI – Cost \$60.00
7. Letter Writing
  - a. Letters written for court will be charged at a rate of \$175.00 per hour for the amount of time it takes to compose the letter.
8. Polygraph Testing
  - a. Pre-Trial Clients:
    1. any client who is in treatment for at least one year prior to sentencing must take and pass a sexual history polygraph.
  - b. Post-Trial Clients:
    1. all post-trial clients must take and pass a sexual history polygraph
    2. all post-trial clients must take and pass an annual maintenance polygraph
