### TUITION PAYMENT OPTIONS & FEDERAL TITLE IV AID 2018-2019

The Financial Aid Office at South Hills & North Hills Beauty Academy administers Federal Title IV aid programs. Applicants to the Cosmetology & Hair Design are eligible for the Federal PELL Grant (Maximum of \$6,056.00), Stafford Loan, and the PLUS Loan program.

All other programs Esthetics Skin Care & Make up, Manicure and Nail Design, and the Instructor Course qualify for Federal Stafford Loan, and the Federal PLUS Loan. Financial Aid begins by creating federal student aid ID (FSA id) for both student and parent [www.fsaaid.ed.gov](http://www.fsaaid.ed.gov) & then completing the FAFSA application at the Financial Aid Office, or by visiting [www.fafsa.gov](http://www.fafsa.gov)

#### You will need to bring the following items to your Enrollment/ Financial Aid Appointment:

1. A copy of a High School Diploma or GED (transcripts are acceptable)
2. A copy of your Social Security Card
3. A copy of your Driver's License or State ID (copy of Legal Resident Card if not a US citizen)
4. \$75.00 non-refundable Enrollment fee (check, cash, or money order only)

#### If applying for Financial Aid:

5. You must know your FSA profile Login and Pass word information
6. A copy of your 2016 Federal Tax Returns
7. Dependents: a copy of Parents 2016 Federal Income Tax returns
