At the time of registration, 20% of tuition fees are required and are non refundable. Charges for tuition are annual, however, once initial payment of 20% has been taken care of at the time of registration, can be broken into ten equal monthly payments from September 2019 until and including June 2020. Payments can be made via post dated cheques or via a credit card authorization. CC Authorization has a onetime fee of \$15.00 added onto September payment to cover transaction costs.

Parents must give 30 days' written notice of withdrawal from class to receive any refunded tuition. **After January 31<sup>st</sup> withdrawals from the program will not be accepted with a refund.** Costume fees for Recreational Students are included in the cost of the program. Costumes do not include tights or footwear.
