IMPORTANT PARENT INFORMATION (Please read and sign):

At the time of registration Star Bound Dance Company requires the registration fee and first month's tuition (non refundable) in order to hold a dancers spot. Payments can then be made monthly **ONLY** via credit card (Visa/MasterCard). Registration will NOT be accepted without a credit card authorization form on file.

Star Bound Dance Company guarantees 33 classes in a September-June season. Our tuition is seasonal broken into monthly payment installments. We **do not accept withdrawals** from our **Performance Program after March 31st, 2023**. Monthly tuition payments WILL be processed for the remainder of the season (April-June).

ALL Performance Level classes at Star Bound Dance Company include the recital costume that students wear for our Year End Recital Showcase in June which takes place at Bert Church Theatre (Recital costumes do NOT include tights or shoes). **Equipment or dance attire/shoes/tights for weekly classes are NOT included in the monthly tuition.**

Students showing signs of potentially transferrable illness are required by the studio to stay at home. This does not include asthmatic or seasonal allergies. We require parents to keep an open line of communication on how students are feeling and help protect the facility environment by keeping students with severe symptoms of any cold, flu, or virus at home until they are feeling better.

This contract releases SBDC, its staff and facility from liability for health related issues. The studio will be maintaining Covid sanitization and requirements throughout our 2022/23 season for the safety of students,

clientele, and teachers. This contract ensures that clientele understand the risks of entering our private facility and that there is a higher risk of contraction of any cold, flu, or virus in any setting where students are participating in indoor events, sports, or fine arts activities.

This contract releases SBDC, its staff and facility from any loss of article or personal possession. SBDC is a private facility with spaces open to the public. These areas are monitored by security cameras for which footage can be solicited by a client; however, SBDC, its staff, and facility are not responsible for facilitating investigations into lost articles. There is a lost and found available at request.

This contract releases SBDC and its staff from all liability for accident or injury that may occur within the SBDC facility or at SBDC sanctioned events. Through this contract the client acknowledges that dance, and in particular Acro dance, is dangerous and at their child's own risk.

SBDC has a no tolerance policy for profanity, indecency, or bullying towards our staff or students. This includes on social media, in email, or in public. Any parent or student who has been felt to cross the line will be removed from our program immediately without refund at the discretion of the Studio Director. SBDC employees will not meet with parents during class time or communicate via personal cell phone numbers or social media messenger programs. Scheduled appointments or emails directed to the teacher must be made through and at the convenience of the studio office. Teachers do not meet with clients alone and will always have another teacher and/or the Office Director present when doing so.

This contract releases photo rights for any photos, videos or prints that may be taken of the client's child throughout the season and through this contract the client acknowledges that these photos and videos are the property of SBDC and may be used in social media, print ads, and advertisements or within the facility.
