WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY

IN CONSIDERATION of being allowed to participate from time to time in the "Training or Instruction" offered by Tactical U, LLC (the "Training or Instruction"); I, on behalf of myself and all of those claiming by, through or under me, hereby represent, warrant and/or agree to the following: 1.
