- **2. Enrollment-** 2013-2014 School year
 - Current enrollment for next year is 292-294, depending upon "maybes". Most recent report attached.
- 3. Marketing Current methods and future projects
 Looking at "door hanger" version of flyer, not "sold" on this "door-to-door"
 concept however. Creating mailers for all likely candidtes in our geographic
 radius. Printing 75 flyers, we will be on "Growing up Fort Collins" listing,
 Google Geo-ad is a good idea going forward. Our grant-writer and our
 Specials teachers are working hard on the Artworks grants.
- 4. Inclement Weather Policy- Review proposal

Reviewed and added "excused absence" policy where there is confusion on the day. This will go into the policy and handbook. We will vote on it next month after we revue the current manual.

5. PTLO- Funds remaining from 2012-2013 school year

PTLO has 17K; they will be funding most of the \$6200 LEGO Mindstorms STEM program going into grade 5+. \$4K earmarked to upgrade memory on student computers, may not all be needed. Planning on signing up with SCRIP services and setting up \$3K worth of cards initially.

-Review proposed Finical Policy; we agree PTLO to board communications will be simple, we don't want to run their

organization, just keep tabs. Helped to set PTLO payout amount limits before the Board needs to approve, and the limit of funds carried over to "jump start" events in the next year. We all agreed this may need tuning as we discover how these costs fluctuate year-to-year.

 Discussing terms with Paul family and Mosaica to cover budget shortfall.
 This discussion is looking favorable with Mosaica and we are waiting for a response from the Paul family toward bond payment terms negotiations. Our current budget is based upon an enrollment of 307.
